#### THE JOHN MERCER LANGSTON BAR ASSOCIATION SCHOLARSHIP FUND

The John Mercer Langston Bar Association Scholarship Fund of the Columbus Bar Foundation was established to recognize and promote the academic achievement of law students in Central Ohio who embody the legacy of John Mercer Langston through:

- Academic excellence and achievement;
- Leadership in community organizations that further the mission of the John Mercer Langston Bar Association; a future career in the legal profession that furthers the mission of the John Mercer Langston Bar Association and the legacy of John Mercer Langston; and
- Achievement through personal milestones or overcoming personal hardships.

John Mercer Langston (1829-1897) was a prominent African American lawyer, politician and public servant who rose to prominence in Ohio. After graduating from Oberlin College, Langston was denied entry to all but one of the law schools to which he applied. He studied law under a judge and passed the bar in 1854, then was elected to public office in 1855 after a brief career as a trial lawyer in private practice. As a civil rights advocate, Langston worked tirelessly as a champion for the cause of including the disenfranchised in the public life of the country. He served as the Education Inspector of the Freedmen's

Bureau, the first Dean of Howard University School of Law, Consul General to the nation of Haiti, president of Virginia Normal College Institute (now Virginia State University), and as a politician, elected to the United States Congress from his home state of Virginia.

The John Mercer Langston Bar Association Scholarship is awarded to law students in Central Ohio who honor the legacy of John Mercer Langston by furthering his ideals- embodied by the John Mercer Langston Bar Association and its mission- in the present day.

## 2023 Gala Keynote Speaker LaDavia S. Drane, Esquire

Global Head of Inclusion, Diversity and Equity at Amazon Web Services

LaDavia Drane is a bridge between the worlds of technology and inclusion, diversity, and equity. Leveraging technology for good, in ways both big and small, and with a global impact is her personal and professional mission. With a background comprised of work and education in public policy, public relations, technology and inclusion, diversity, and equity, LaDavia has cultivated strategically aligned relationships to remove barriers and build opportunities that accelerate equity in the circles she navigates and beyond. LaDavia lives out her mission, daily, as the Global Head of Inclusion, Diversity, and Equity for Amazon Web Services. Prior to this role, she served as the U.S. Public Policy Head of Diversity & Inclusion for Amazon. After earning a Juris Doctorate from the Cleveland-Marshall College of Law at Cleveland State University, LaDavia joined Ulmer & Berne LLP, in Cleveland, as a law associate. A drive to impact change propelled LaDavia to move to Washington, D.C. to launch a career in politics and public policy. That decision gave rise to a successful career on Capitol Hill that included stints as Chief of Staff, Legislative Director and Executive Director for the Congressional Black Caucus, and as the Director of Federal and Regional Affairs for DC Mayor Muriel Bowser.

LaDavia utilized her relationship management and coalition-building skillset as the Director of African American Outreach and Deputy Director of Congressional Affairs for Secretary Hillary Clinton's 2016 presidential campaign. LaDavia's community service is as inclusive and diverse as her professional



work. She is an Amazon Women@Amazon Executive Sponsor and Amazon Black Employee Network Executive Sponsor. She is the Co-Chair of NPower and a Corporate Partner for Girls in Tech, Women in Cloud. In addition, LaDavia serves as Corporate Partner for the Martin Luther King, Jr. Memorial and as a Corporate Board Member for the Smithsonian National Museum of African American History and Culture. In addition, she is also a Congressional Black Caucus Foundation Board Member, COSI Board Member, Martin Luther King, Jr. Memorial Foundation Board Member and on the Miami University Alumni Board.

# 2023 Legacy Award Winner The Honorable Janet E. Jackson



Janet E. Jackson spent 14 years as president and CEO of United Way of Central Ohio, one of the largest United Way organizations in the country. She was the first woman and the first African American to lead the organization.

Prior to coming to United Way, Janet served six years as Columbus City Attorney, a first for a woman in Columbus. Her election to that office was also a first for an African American. As Columbus City Attorney, she served as the City's chief legal advisor.

Before her appointment as City Attorney, Janet served nearly ten years as a Franklin County Municipal Court judge, making her the first African-American female judge in Franklin County history. She holds a B.A. degree from Wittenberg University and a J.D. degree from The National Law Center at George Washington University.

Under Janet's leadership, United Way of Central Ohio steadily expanded its position as an organization that goes far beyond fundraising to mobilize its community to comprehensively address the root causes of poverty and create lasting, measurable change. She has been instrumental in educating local business and community leaders about poverty in central Ohio and in inspiring them to join with United Way in developing an integrated approach to providing the opportunities people need to rise above poverty.

Her honors and awards include: Allies of Equality Award from Equality Ohio, Woman of Achievement Award from the YWCA of Columbus, the Dr. Martin Luther King, Jr. Humanitarian Award from the Columbus Education Association, 2013 Professional Woman of the Year by the Women of Color Foundation and Woman of the Year by the Niagara Foundation. She was inducted into the Ohio Women's Hall of Fame in 2001. She also received the 2015 Mortar Board Alumni Achievement Award and an honorary Doctor of Law degree from Capital University Law School. She was named Outstanding Head of Diversity in the Columbus Business First Diversity in Business Awards and won the Champions of Diversity Legend Award.

Janet is member of the board of Installed Building Products (a publicly traded company) and chair of its compensation committee. She also serves on the board of Wittenberg University. She served as a member of the Task Force to Prevent Family Homelessness. Janet is proud to have served as Chair of the Columbus Community Safety Advisory Commission and currently serves as Chair of the Civilian Police Review Board. She is also a member of the International Women's Forum, IWF Ohio and Women Corporate Directors. She also serves on the Siemer Institute National Advisory Council and on the board of the Jazz Arts Group.
